Survey Content

- The Framework for Our Future housing survey asked participants to rank housing priorities, needs, and share housing experiences
- The results will allow the *Framework* to address communities needs identified by participants

Process

- Survey distribution
 - Input Expos
 - Emails to Grand Vision networks, collaborative bodies, local governments
 - Press releases
 - Hard copies were distributed to/by county collaborative groups to include a wider demographic
- 400+ surveys received; majority completed online

Demographics: Residency

 Almost 50% of survey respondents were members of Grand Traverse County

"Other" category included: Benzie, Calhoun, Charlevoix, Emmet, Manistee, Mason, Missauke, Muskegon, Otsego, and Ottawa County

Demographics: Annual Income

- A majority (55%) of respondents were employed full time
- A majority of respondents (65%) made \$50,000 or more per year



Demographics: Age

- Almost all respondents (98%) were over 25 years old
- Almost 3/4 (71%) of respondents were over 45 years

Results Overview: Housing Choice

- Participants felt their communities' housing needs were not being met in the areas of price, type, accessibility, energy efficiency, and walkability
 - Respondents reported that their communities needed more affordable and higher quality housing, although they didn't believe mobile housing was the answer to this issue
 - Respondents also indicated the need for housing to be closer to daily life and a desire to build in these locations
 - Many housing issues were financially-related

Results Overview: Housing Discrimination

- Comments indicated that many respondents did not believe discrimination was an issue in northern Michigan
- Most housing discrimination was:
 - Believed to be based on age
 - Done by an apartment complex or rental unit
 - Occurred in Grand Traverse County
- Most respondents did not report discrimination because they believed it would not have made a difference

Housing Choices: Location

- Strong consensus around the need for more housing choices that are:
 - Close to jobs, schools, services, and shopping (81%)
 - Walkable (78%)
 - Close to activities, entertainment, etc. (74%)
- New housing choices in rural areas were less highly prioritized

Housing Choices: Type

- A strong majority of participants indicated that their communities need more energy efficient (84.8%) and affordable (84%) housing
- Participants were less likely to answer that larger homes are a need versus smaller homes
- Strong consensus that additional mobile homes are not a priority

- Accessibility and location in rural areas received lower priority rankings

Question Analysis: Housing Factors



#4. I would be willing to pay more for my housing if I paid less for transportation costs.



 Over half (53 %) of respondents felt positively about paying more for housing in return for lower transportation costs. #5. I would be willing to pay more for my housing if I paid less for energy or utility costs (such as heat, electricity).



 Almost 3/4 (73.3%) of respondents felt positively about paying more for housing in return for lower energy or utility costs. #6. In your opinion, have you ever been discriminated against, when seeking to buy or rent housing, for any of the following reasons?



"Other" comments included suggestions for additional categories (or personal experiences): pets, number of children, sexual orientation, socioeconomic status, criminal record
